**Meeting Minutes**

November 14, 2022

- I. **Call to Order.** The Council convened in a regular meeting on November 14, 2022 at 6:30 p.m. in the Commissioner's Courtroom.
- II. **Pledge of Allegiance to the Flag.**
- III. **Roll Call.** Members present were, William Rennels, Rick Weir, Kelly Summerville, William Brent Bush, Martin Brown, Randy Dreher, Auditor Brenda Furry, Deputy Auditor Annie Wickens, and County Council Attorney, DJ Bonomo. Ashley James was not present at the meeting.
- IV. **Approval of Minutes.** A motion was made to approve the minutes from October 3, 2022 and October 12, 2022 by Brown and seconded by Summerville. All in favor, motion carried.
- V. **Treasurer's Report.** Vice President, Weir acknowledged receipt of the Treasurer's Report.
- VI. **Transfer of Fund- Non-Reporting-**
