

**Vermillion County Council**  
**Meeting Minutes**

April 11, 2022

6:30 P.M.

- I. **Call to Order.** The Council convened in a regular meeting on April 11, 2022 at 6:30 p.m. in the Commissioner's Courtroom.
- II. **Pledge of Allegiance to the Flag.**
- III. **Roll Call.** Members present were President Ashley James, William Rennels, Rick Weir, Kelly Summerville, William Brent Bush, Martin Brown, Auditor Brenda Furry, Deputy Auditor Annie Wickens, and County Council Attorney, DJ Bonomo. Randy Dreher was not present.
- IV. **Approval of Minutes.** A motion was made to approve the meeting minutes from March 14, 2022 by Bush and seconded by Brown. All in favor, motion carried.
- V. **Treasurer's Report.** President, James acknowledged receipt of the Treasurer's Report.
- VI. **Transfers**
  - Reporting only**
    - Transferred from 1000-31801-150 (\$3400.00) & 1000-31700-150 (\$1725.00) to 1000-31401-150 in the amount of \$5,125.00 . No approval needed.
  - Council Approval**
    - Transferring from 1000-03404-108/Overpayments (\$1808.07) to 1000-32200-108/Postage. This is an overpayment made to Quadient for postage. Auditor receipted in and needs it appropriated back to the prosecutor's postage account. A motion was made by Bush to approve the transfer of \$1808.07 and was seconded by Brown. All in favor, motion carried.
    - Transferring from 1000-03367-132/Ins Reimbursement to 1000-21800-105/other Garage repair. This was for a comp loss for the 2018 Ford Explorer. This will pay the remainder of the invoice. A motion was made to approve the transfer of \$630.44 by Brown and seconded by Summerville. All in favor, motion carried.
    - Transferring from 1222-21203-263/E911 Office Supplies (\$1500.00) to 1222-32103-263 (\$750.00) and 1222-32400 (\$750.00) for the new E911 Admin to go to Conference. A motion was made by Bush to approve the transfer of \$1500.00 and was seconded by Weir. All in favor, motion carried.
    - Transferring from 8128 Opioid to 1213 Peer Court. Per Auditor moving Opioid to Peer Court from Budget Hearings. (\$60,000) A motion was made by Brown to approve the transfer in the amount of \$60,000 and was seconded by Rennels. All in favor, motion carried.
- VII. **Additional Appropriations**
  - **Commissioners Court** 1000-12901-000-0130 in the amount of \$30,215. Per Auditor, the payment made each year has been incorrect for the Sheriff's Dept Retirement. This will correct the back payments and have the county up to date for 2022. A motion was made by Rennels to approve the additional appropriations for \$30,215 and was seconded by Summerville, All in favor, motion carried.
  - **Park & Recreation** 1179 Non-Reverting Parks fund in the amount of \$108,000 and then transferring to the 1000-41402-146 to purchase and update playground equipment in some of the County Parks. Wayne Bush spoke with the council on

the things that the parks department will be doing and updating. Bush stated that they will be putting a work out area in the Perrysville park with 5 stations to do different workouts. Bush also stated that they are putting a 5-hole frisbee course at the Saint Bernice park. Weir stated he hopes that the playground equipment will be ADH accessible. Bush stated that yes that it was. A motion was made by Brown to approve the additional appropriation in the amount of \$108,000 and was seconded by Weir. All in favor, motion carried.
