- James states that the county jail is asking to transfer \$15,000.00 from improvements to electricity & natural gas. Summerville makes the motion to approve the transfer. Bose seconds the motion. All in favor, motion carried.
- James states that the surveyor is asking to transfer \$2,952.00 from office supplies, surveyor supplies, and professional services to part time help. Weir makes a motion to approve the surveyors transfer. Ms. Brown seconds the motion. All in favor, motion carried.

- James explains that Economic Development is asking for an additional which was a grant received from Duke Energy. The grant received was for \$5,000.00. They are wanting to add \$4,000.00 to capital outlays and \$1,000.00 to dues & subscriptions. Weir makes the motion to approve the additional for economic development. Bose seconds the motion. All in favor, motion carried.
- James explains that the Highway Department received a refund of \$249,134.66 from Asphalt Materials, they are asking for the money to be placed back into the 1176 fund for bituminous. Summerville makes a motion to approve the additional. Mr. Brown seconds the motion. All in favor, motion carried.
- James explains that the Auditor's Office is requesting an additional of \$999,839.42 in the Community Crossing Grant Fund to pay for the 2023-1 CCMG projects. Costello makes the motion to approve the additional. Weir seconds the motion. All in favor, motion carried.
- IX. Old Business
  - a. 2024 Budget Resolution 2023-13
  - James opens the meeting up for questions about the 2024 budget. Alexander comes to ask questions about the Prosecutor's budgets regarding salaries. The council answers her questions about the budgets and salaries. Aukerman also comes to ask questions about the 2024 salaries. The council answers his questions also. Weir makes the motion to approve the 2024 budget resolution 2023-13. Mr. Brown seconds the motion. All in favor, motion carried.
  - b. Solid Waste Budget Resolution 2023-14
  - James states the adopted budget for solid waste is \$12,000.00. Weir makes the motion to approve the budget. Ms. Brown seconds the motion. All in favor, motion carried.

- XI. SR 163 Bridge at Brouiletts Creek Property Acquisition Approval
  - Ms. Yocum explains that INDOT is wanting to buy some land under the 163 & Brouiletts Creek bridge for \$1,000.00 Bose makes a motion to accept the \$1,000.00 offer from the state for the property and to have Tim Yocum and Britton Luther sign the acceptance offer and the Warranty Deed. Costello seconds the motion. All in favor, motion carried.
- XII. Public Comment
  - Surveyor Mack comes to ask about his additional that wasn't discussed at the meeting. Ms. Yocum explains that it didn't get put into the paper. Mack asks if anything can be done to get approval because he needs the money to cover a bill for engineering services. Auditor Furry states that she has \$14,000.00 in her budget's professional services that she is offering to transfer to the surveyor until the November meeting. Weir makes a motion to approve a \$14,000 transfer from the Auditor's professional services to the surveyor. Summerville seconds the motion. All in favor, motion carried. Ms. Brown didn't vote.
