- f. Budget Agreement for Cox, Zwerner, Gambill & Sullivan

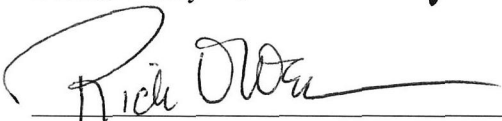
