Meeting Minutes

July 19, 2021

6:30 P.M.

Commissioner's Court, 2nd Floor Courthouse

- I. **Call to Order.** The Council convened in a regular meeting on July 19, 2021 at 6:30 p.m. in the Commissioner's Courtroom.
- II. **Pledge of Allegiance to the Flag.**
- III. **Roll Call.** Members present were President Ashley James, Vice President Randy Dreher, William Brent Bush, Rick Weir, Neil Costello, Kelly Summerville, Martin Brown, Auditor, Brenda Furry, Chief Deputy Auditor, Annie Wickens, and County Council Attorney, DJ Bonomo.
- IV. **Approval of Minutes.** James acknowledge the June 14, 2021 and June 29, 2021 meeting minutes. A motion was made to approve the June 14, 2021 meeting minutes by Weir and seconded by Brown. A motion was made to approve the June 29, 2021 minutes by Bush and seconded by Costello. All in favor, motion carried.
- V. **Treasurer's Report.** President, James acknowledged receipt of the Trust Indiana report and the Treasurer's monthly report.
- VI. **Comp Time Report.** President, James acknowledged receipt of the Comp Time Report. Costello asked if the these were monthly numbers and Auditor Brenda Furry stated that yes, they are monthly. Costello also questioned the increase in the Extensions Comp hours. Furry stated that was for the fair.
- VII. **Transfer of Funds-Approval by Council-**
1000 County General Location 130-transferring from 30270-130 Publications to 21200-000-0130 Supplies. This was inadvertently paid out of the Publications and should have been paid out of Supplies. A motion was made by Bush to approve the transfer of funds and seconded by Brown. All in favor, motion carried.

- VIII. **Additional Appropriations.** The Council considered additional appropriations as published. President Ashley James reviewed the appropriations from the written requests submitted by Auditor Brenda Furry. Thus, the following ordinance was adopted: WHEREAS: it has been determined it is now necessary to appropriate more money that was appropriated in the annual budget for 2021, BE IT ORDAINED, by the County Council of Vermillion County Indiana, for the expenses of said county government, the following additional sums of money are hereby appropriated and ordered set out of the funds herein specified, subject to the law governing the same:

This Bridge was hit by a drunk driver and did a considerable amount of damage to the whole structure. James stated that having these additional appropriations approved that it would deplete the Cum Bridge Fund and that the Department would need to understand this issue. There was a lengthy discussion on the bridge and culverts between Costello and Commissioner Britton Luther. A motion was made by Costello to approve the additional appropriation and was seconded by Summerville. All in favor, motion carried.

Britton Luther stated that the contract that the County has now is not very well written and is not specific enough on the details. Contract needs rewritten.

Wendy Farley from the Health Department stated that they have cut the hours of the clinics to 13 hours a week. Summerville requested that we close the clinics. Farley said the Health Department is required by the State to conduct clinics.

IX. Open Issues

- a. Salary Study-James stated that the Salary Study was back and that the Council put together a committee to go over the numbers from the Salary Study. The Salary Study had several different aspects to it and the Committee was still going over the numbers and but would like to make a proposal of giving \$1000 across the board to the employees for 2021 and then implementing the new salaries in 2022. James stated that the Council had budgeted the \$1000 for 2021, and that this would be the best way to implement the Salary Study. Penney Carpenter stated that back on September 15, 2020 that the Council stated they would retro-active the pay raises to the beginning of 2020, and then again on June 14, 2021 meeting. James explained that the Council was wanting to do that but believes that this would cause a much bigger issue and would be a lot of work due to different employees get paid out of different funds and not just one. She believes that the raises that the employees will get are good raises and believes that everyone will be happy with the amounts for 2022. Bruce Aukerman stated that he would just like to see the Salary Study results. James stated that once the Committee gets the numbers finalized she doesn't have a problem giving the Salary Study out, but would like to finalized the salary amounts. A motion was made by Bush to allow the employees to get \$1000 salary stipend for year 2021 and was seconded by Brown, all in favor, motion carried. Weir wanted to know when the payment of the \$1000 would pay out and James stated that she would speak with Payroll and get it out as soon as possible. This does not include the Elected Officials. Florinda Pruitt requested that at budget hearings it possible would the Council mind letting the elected officials know what was approved from the Council. James stated she wasn't aware that the departments didn't know what their approved budget was. Several people stated they don't know what was approved until after the first of the year. Pruitt stated she would like to have the Council bring the elected Official back into hearings and tell them what is approved and what is not approved and why.

X. New Business

- a. Vermillion County Sheriff Commissary Fund-James acknowledged receipt of Commissary Fund from the Sheriff.

- b. Budget Contract for Cox, Zwerner, Gambill & Sullivan for 2022 budget. This contract is used every year by the County for Consulting fees for the Budgets. A motion to approve Budget Consulting Agreement was made by Dreher and seconded by Bush. All in favor, motion carried.


