- I. **CALL TO ORDER**: The Vermillion County Council convened in a regular meeting at 4:30 p.m. on Monday September 8, 2014
- II. **ROLL CALL:** Members present were President Michael Carty, Vice-President Jill Wesch, Michael Costello, Randy Dreher, James McLain, Milisa Carty, Auditor Phyllis Orman, First Deputy Amy Tolbert, and Attorney Don Darnell. William Brent Bush was present at 5:05 p.m.
- III. **MINUTES**: The minutes from August 11, 2014were approved on a motion made by Michael Costello and seconded by Randy Dreher. The motion carried unanimously.
- IV. **COMP TIME:** Michael Carty acknowledged receipt of the comp time report. He stated it had decreased by \$4,000.00. He said there are still some questions as to who is eligible to receive comp time.
- V. **TRANSFER OF FUNDS:** The Council approved the request for the transfer of funds. The following resolution was adopted.

President Michael Carty reviewed the appropriations from the written requests submitted by Auditor Phyllis Orman. Thus, the following ordinance was adopted: WHEREAS: it has been determined it is now necessary to appropriate more money than was appropriated in the annual budget for 2014, BE IT ORDAINED, by the County Council of Vermillion County Indiana, for the expenses of said county government, the following additional sums of money are hereby appropriated and ordered set out of the funds herein specified, subject to the law governing the same:

#### VII. **OPEN ISSUES:**

- Soil & Water update. Michael Carty said he still had questions about overtime and comp time. He asked that it be brought before the Commissioners and that the council be made aware of that meeting.
- County Economic Development Income Tax. The Council decided not to raise the Economic Development Income Tax (EDIT). Dreher asked if the tax could be lowered because they are not satisfied with the Highway Departments plans for the money. Michael Carty said it could but stated that Economic Development probably needs that money.
- Newport Chemical Depot Reuse Authority. Director Bill Laubernds reported that the jail sewer project is moving a long and should be completed in November. He said they are

looking into grants to cover the cost of remediating the septic system that will be left when the new system is finished. He also explained that they have not been charging the jail for water but will need to start charging soon.

### VIII. NEW BUSINESS:

- Clinton Library Bond. Clinton Public Library is wanting to borrow \$500,000 for a new roof, heating ventilation and air conditioning (HVAC) system, and drainage repairs. Michael Costello made a motion to approve Resolution 2014-005, seconded by Jill Wesch. All were in favor.
- 2015 Budget Public Hearing& Non-binding reviews. Michael Carty read the 2015 proposed budget totals and asked if the audience had any questions. The council reviewed the non-binding reviews. Costello moved to give favorable consideration to the reviews as submitted, seconded by McLain. All were in favor.
