The Public Defender Board is requesting money to pay for a secretary and to operate a Public Defender's office. The request is for a salary for a full time secretary and also office equipment and supplies.

It was explained that these expenses would be reimbursed from the state at 40%. Judge Stengel explained the need for the secretary and the office space. Prosecutor Bruce Aukerman stated that there is a conflict of interest when the defendants are calling his office for information. Judge Stengel also expressed the need of the office space so the Public Defenders would have somewhere to take their clients to talk in private. Costello said he would like to know how many calls the Prosecutor and Judge's office receive for the Public Defenders. Michael Carty suggested they table the matter until they can get more information about the call volume. He also stated the request should be presented in 2015 as this is the end of the year and the person would not be paid until 2015. Public Defender Jeff Thomas stressed the need for this office. He said it would allow people a place to call to get court dates and to get answers to questions they may have. Michael Carty said he also would like to know who will be in charge of this person, would they be monitored and if there would be an opportunity for overtime. He said he would also like to see a job description. Bush moved to table the matter until all questions were answered. Dreher seconded the motion, All were in favor.

VII. OPEN ISSUES:

- Newport Chemical Depot Reuse Authority. Elizabeth Burrows emailed a Report on Federal Grants dated December 8, 2014. Michael Carty stated that Suzie Jones works for the county but also assists the Reuse Authority. He said he does not know whether she gets a stipend from the Reuse Authority.
- County Engineer. Milisa said she has spoken with LTAP and they will be setting up an appointment in the near future.

VIII. **NEW BUSINESS:**

- Wheel/Surtax. With changes being made by the state a new ordinance will need to be prepared. The information was sent to Darnell. Darnell prepared the new ordinance. Bush made a motion to allow, seconded by Dreher. All were in favor.
- Highway 3 year plan. The Commissioner's presented the Council with the plan prepared by West Central. The Council will review it and asked that someone from West Central come and explain it to them. Tabled.
- 2015 Meeting Schedule. Costello made a motion to allow, seconded by Wesch. All were in favor.
- Sheriff Salary for 2015. Michael Phelps said he has the Compensation Agreement prepared. He said it is exactly the same as the contract with the current Sheriff. Michael Carty said they will take it under advisement. He is not sure why the council has to approve it because the Commissioners approve contracts.
