- I. **CALL TO ORDER**: The Vermillion County Council convened in a meeting at 6:30 p.m. on Monday June 8, 2015
- II. **ROLL CALL:** Members present were President Michael Carty, Vice-President Michael Costello, Randy Dreher, James McLain, Milisa Carty, William Brent Bush, Jill Wesch, Auditor Phyllis Orman, First Deputy Amy Tolbert and Attorney Don Darnell.
- III. **MINUTES**: The meeting minutes from May 11, 2015 and the joint meeting on May 11, 2015were approved a motion made by Costello and seconded by Wesch. The motion carried unanimously.
- IV. **COMP TIME:** Mike Carty reported that the current liability decreased approximately \$4,000.00. \$3,700.00 of that was in the Highway Department. Dreher asked what was going on with the Prosecutors overtime and Michael Carty said it is still up in the air, the commissioners are looking into it. Commissioner Tim Wilson said the proposed changes to the handbook have been through the first reading and it will be decided upon at the meeting on June 16, 2015. Michael Carty said the issue of the accumulated time will be the next issue to take care of.
- V. **COUNTY TREASURER'S MONTHLY REPORT.** Michael Carty acknowledged receipt of the report.

IX. **NEW BUSINESS:**

- Compliance with Statement of Benefits for Tin Inc. and Eli Lilly. Michael Carty said this is an annual requirement and just a matter of record. He said they are required to file this report yearly. It is not a new abatement. There was some discussion as to whether Economic Development should review it first. It was decided they should. Michael Carty moved to table it until the next meeting.
- E911. E911 Director Derek Williams said he will be presenting an additional appropriation next month to pay for the reprogramming of the new radios and the removal of the old, outdated software.
- EOC Road signs. EOC Director Mark O'Heir reported that the 6 signs the county owns are not in very good shape and he has been unable to find a company that will repair them. He did find a company that will take new parts and reconstruct our signs for \$9,800.00 per sign. He said he will submit an additional next month for \$20,000.00 to cover 2 signs. He will then ask for another \$20,000.00 in 2016's budget and then another \$20,000.00 in 2017's budget and that will take care of all 6 signs. He said to purchase a new sign would cost \$25,000.00.
