Vermillion County Council Meeting Agenda/Minutes

- I. CALL TO ORDER: The Vermillion County Council convened in a meeting at 6:30 p.m. on Monday August 10, 2015
- II. **ROLL CALL:** Members present were President Michael Carty, Vice-President Michael Costello, Randy Dreher, James McLain, Milisa Carty, Jill Wesch, William Brent Bush, First Deputy Amy Tolbert and Attorney Don Darnell.
- III. **MINUTES**: The meeting minutes from July 13, 2015 were approved a motion made by Weschand seconded by McLain. The motion carried unanimously.
- IV. **COMP TIME:** Mike Carty reported that they had just received the comp time report and has not had a chance to review it but said it appears to have gone down around \$1,000.00. He said he would like to see a break out of the hours over 40 for everyone except the Highway and Jail. He said they need to discuss the contingent liability that this report represents. He said currently he is aware of 2 people that are wanting to claim comp time and has heard there will be more. He stated no one is being paid at this time because no one has submitted a claim. Commissioner President Tim Wilson said they need to make sure the claims that are submitted are legitimate claims and if not they will turn it over to the state police for investigation. Michael Carty suggested they have the county attorney, Jon Spurr, work with State Board of Accounts to review the claims. He said he would like for the issue to be resolved before budget hearings. McLain suggested they put a stipulation on the time frame of when people can turn in a claim. Attorney Don Darnell said there should a reasonable time period to file a claim. Michael Carty said they will have the State Board of Accounts address it and said a precedence was set when they paid the former Sheriff for time owed. Darnell said that was a different scenario, he had documentation to back that up. Costello said he still has some questions about a few on the list that are claiming comp time that he feels should not be and suggested that look into that in the near future as well. Michael Carty said the new handbook does define exempt and non-exempt employees. He said it all falls back to the federal guidelines.
- V. **COUNTY TREASURER'S MONTHLY REPORT.** Michael Carty acknowledged receipt of the report.
- VI. **ADDITIONAL APPROPRIATION REQUESTS**: The Council considered additional appropriation requests as published. President Michael Carty reviewed the appropriations from the written requests submitted by Auditor Phyllis Orman. Thus, the following ordinance was adopted: WHEREAS: it has been determined it is now necessary to appropriate more money than was appropriated in the annual budget for 2015, BE IT ORDAINED, by the County Council of Vermillion County Indiana, for the expenses of said county government, the following additional sums of money are hereby appropriated and ordered set out of the funds herein specified, subject to the law governing the same:
